### **Jeep Official Rules**

This draw is run and administered by Trading Enterprises Co LLC (the "Dealer"), <u>in collaboration with</u>, <u>and sponsored by</u> **Stellantis Middle East FZE** <u>("Jeep")</u> (together referred to as the "**Sponsors**"). By entering the prize draw ("**Draw**"), you ("**you**" "**your**" "**winner**") agree to be bound by these terms ("**Official Rules**"), and by the decisions of the Sponsors, relating to the Draw.

## How to enter
